ARTICLE I-NAME

The name of this corporation is AL T. MAGLIANO INTERIORS, INC.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of carpentry, remodeling, construction, and transacting any and all lawful business permitted under the laws of Florida.


ARTICLE IX - INDEMNIFICATION



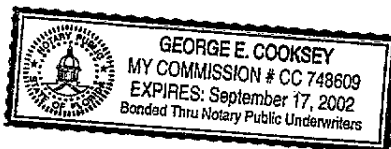
