ARTICLE I. NAME

The name of the corporation shall be: **MUZIK ETC... PRODUCTIONS, Inc.** This shall be a for-profit corporation established within the state of Florida.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 9018 SW 150 AVENUE, Miami, FL 33196

ARTICLE III. SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 at \$ 1 par value.


