The undersigned, for the purpose of forming a corporation, adopts the following
Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Wolf Marketing Group, Inc., and its address is 49
Deer Creek Rd. #E103 Deerfield Beach, Florida 33442.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

- (1) To transact any and all lawful business for which corporations
may be incorporated under the Florida General Corporation

- (2) To do such other things as are incidental to the foregoing or
