In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation

ARTICLE 1 - CORPORATE NAME

The name of this corporation is G.C.M. TRANSPORT, INC..

ARTICLE 2 - PRINCIPAL OFFICE

The principal place of business of this corporation is 17391 N.W. 11<sup>th</sup> Street, Blountstown, Florida 32424, and the mailing address of the corporation is P.O. Box 444, Blountstown, Florida 32424.

ARTICLE 3 - CAPITAL STOCK

ARTICLE 4 - INITIAL REGISTERED AGENT AND OFFICE

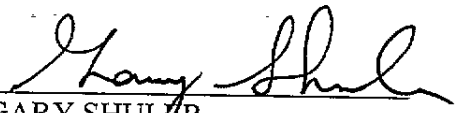

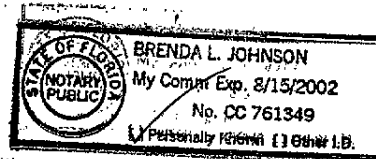

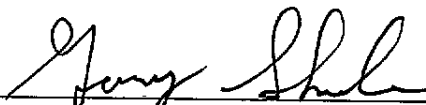
