The business of the corporation shall be managed by the stockholders and there shall be no directors.

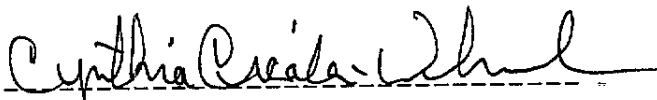
**Article X**

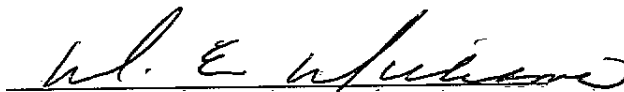


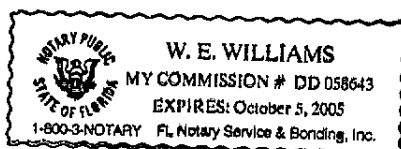
