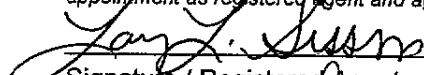
ARTICLE VIII

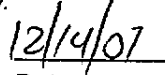

ARTICLE VIV

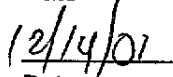
The effective date for the corporation is January 1, 2002.
