ARTICLE I - CORPORATE NAME

The name of this corporation is TREASURE CUTS, INC., whose principal office and mailing address is 3420 N. U.S. HIGHWAY 1, MELBOURNE, FLORIDA 32935.

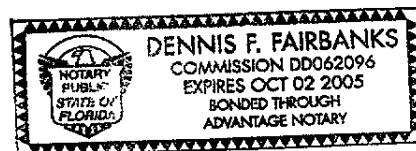
