**AMENDMENT TO ARTICLES OF INCORPORATION  
OF

WHEREAS, the amendment was approved and adopted by all of the stockholders comprising the only voting group of stockholders of Sunmark Title Insurance Group, Inc. pursuant to the provisions of Section 607.0704 of the Florida Statutes, on the 9<sup>th</sup> day of February, 2007; and

WHEREAS, the approval by the Florida Secretary of State of the amendment hereinafter set forth is hereby requested and the amendment shall become effective upon the filing of the same with the Florida Secretary of State.

NOW, THEREFORE, the Articles of Incorporation of Sunmark Title Insurance Group, Inc. are hereby amended, by deleting in its entirety the present Article I and by substituting therefor the following, to-wit:
