Pursuant to the Florida General Corporation Act, the undersigned being the incorporator (s) with respect to these Articles of Incorporation, State of Florida:

1. Name: Access Graphix, Inc

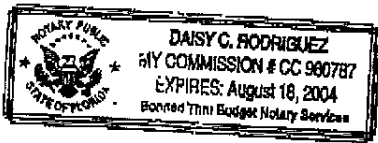
