AN 9: 25 We, the undersigned incorporators, hereby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida

ARTICLE I

The name of the corporation shall be BEZDEK TREE ARBORIST, INC.

ARTICLE II PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 5526 Golden Eagle Circle, Palm Beach Gardens, County of Palm Beach, State of Florida, 33418. The corporation shall have the power to move the principal office to any other address in the State of Florida, as may be deemed expedient.
