

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is ALLIANCE BAILBONDS AGENCY, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE XVIII - DIRECTOR QUORUM AND VOTING
