

It was brought to our attention that our corporation status was inactive. When we called to update our status we were told that as of September 19, 2003 our corporation was dissolved. Ruby Dunlap a representative of the Division of Corporation informed us that the reason our corporation was dissolved was because the Division never received the correspondent request that stated our registered agent's information. When I had her check the address to where this correspondent request was sent, we found that it was sent to an address that no longer belonged to us enclosed you will find the letter that was sent with the wrong address. So we were never aware that this correspondent letter was even sent to us. That same year we did send the fee for \$150.00 dollars to reinstate our corporation for the 2003 year. However since we did not receive this information, our corporation was still penalized and dissolved, hence our check is still being held with the Division of Corporation. Please note that since this letter was sent to a different address there was no way for us to know that our corporation was in danger of getting dissolved
