**PERSONAL INJURY CLINIC OF TAMPA BAY, INC.**

The undersigned incorporator, having legal competency to contract, hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

**ARTICLE I - NAME**

The name of the Corporation is **PERSONAL INJURY CLINIC OF TAMPA BAY, INC.** The initial principal place of business shall be 701 W. MLK Blvd., #5, Tampa, FL 33603, and the mailing address shall be the same.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation may engage in and conduct any lawful business or activities permitted under the laws of Florida and the United States, or any other jurisdiction.

**ARTICLE III - CAPITAL STOCK**

The Corporation shall be authorized to have a maximum number of shares of stock outstanding at any one time of One Hundred Thousand (100,000), shares of common stock having a par value of one dollar (\$1.00) per share.

**ARTICLE IV - REGISTERED AGENT**

The initial Registered Agent shall be Laurie E. Ohall, Esq., and the initial Registered Office shall be 611 W. Azeele Street, Tampa, Florida 33606.

**ARTICLE V - DURATION**

The Corporation shall have perpetual existence.

#### ARTICLE VI - SPECIAL PROVISION

It is intended that the Corporation qualify under section 1244 of the Internal Revenue Code.

#### ARTICLE VII - DIRECTORS

The initial Board of Directors shall consist of one(1) Director, whose name and post office address is as follows:

who shall hold office until the first annual meeting of the shareholders, and until her successor(s) shall have been elected and qualified or until her earlier resignation, removal from office or death.

The number of Directors may be increased or decreased from time to time by Amendment of the By-Laws, but no decrease shall have the effect of shortening the term of any incumbent Director. The number of Directors shall never be less than one (1).



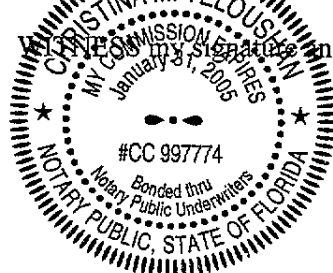
