ARTICLES OF INCORPORATION

OF

MANLEY & ASSOCIATES, CPA'S, P. A.

The undersigned, who is licensed or otherwise legally authorized to practice the profession of public accounting in the State of Florida, for the purpose of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is MANLEY & ASSOCIATES, CPA'S, P.A.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The corporation is organized for the sole and specific purpose of practicing the profession of public accounting and performing and providing the services of certified public accountants.

ARTICLE FOUR
CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida, including, but not limited to, the following: owning, leasing or otherwise holding interest in real and personal property; borrowing money from any individual, bank, savings and loan association, land bank association or production or farm credit association; encumbering any real or personal property owned by the corporation.

ARTICLE FIVE
CAPITAL STOCK

The aggregate number of shares that the corporation has the authority to issue is One Hundred (100) shares, all of which shall be common shares with par value of \$1.00.

ARTICLE SIX
PREEMPTIVE RIGHTS

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe or to acquire any unissued or treasury shares.

ARTICLE SEVEN
REGISTERED OFFICE

The street address of the initial registered office of the corporation is 203 South Seventh Avenue, Wauchula, Florida, and the name of the initial registered agent at that address is Michael D. Manley.

ARTICLE EIGHT






