**ARTICLES OF INCORPORATION
OF
ALBERT CID, INC.**

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation (hereinafter referred to as the "Corporation") is Albert Cid, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

PURPOSE**


