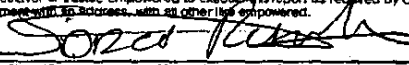

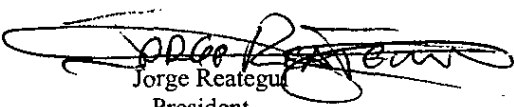
I am writing this letter to inform you that I have been out of the country for the last four months due To my father's illness. And have also moved from my previous address.
