ARTICLES OF INCORPORATION OF

Dr's Auto Clinic, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME

The name of the corporation shall be: Dr's Auto Clinic, Inc.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in the business of automotive repair.

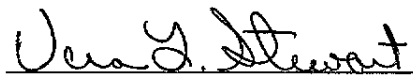

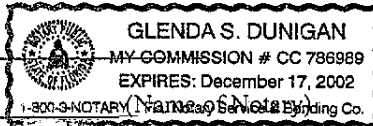

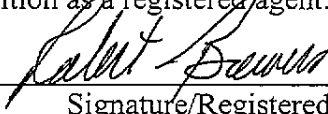
