#### ARTICLES OF INCORPORATION

#### ARTICLE I NAME

The name of the Corporation is FAITHFUL TREASURES, INC. The address of the Corporation is 17512 Drake Court, Lutz, Florida 33549.

#### ARTICLE II DURATION

The Corporation shall have perpetual existence.

#### ARTICLE III PURPOSE
