CORPORATE EXISTENCE

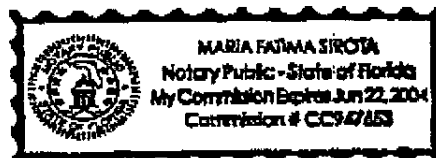
