ARTICLE X.


**Indemnification of Directors

ARTICLE XI.**Amendment**


These Articles of Incorporation may be amended in any manner now or hereafter provided for by law and all rights conferred upon shareholders hereunder are granted subject to this reservation.

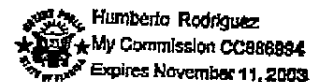
