STATE OF FLORIDA ARTICLES OF INCORPORATION OF

OLORGIA PROPERTY OF THE PROPER TOWNE DEVELOPMENT OF GREYHAWK LANDING, INC.

The undersigned, acting as sole incorporator of a corporation under the F General Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is Towne Development of GreyHawk Landing, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The date and time of the commencement of the corporate existence is the time of filing of these Articles by the Florida Department State.

FOURTH: The purpose or purposes for which the corporation is organized are: to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.
