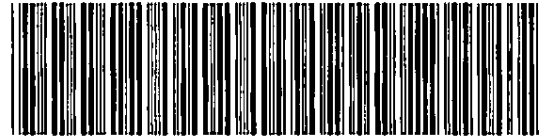

Adoption of Dissolution


Dissolution was approved by the Shareholders of the Corporation on January 2, 2018. The number of votes cast for dissolution was sufficient for approval.

These Articles shall be effective upon filing.

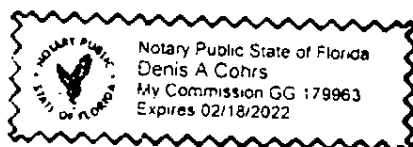
