ARTICLES OF INCORPORATION OF VICTORIA ROTH-ROBERTSON, P.A.

The undersigned subscriber to these Articles of Incorporation, Victoria Roth-Robertson ETARY OF STATE TALLAHASSEE, FLORIC being a natural person competent to contract, hereby acknowledges and files these ARTICLES

OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the provisions of Chapter 607, Florida General Corporation

Act and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes does hereby adopt the following Articles of Incorporation:

ARTICLE I

CORPORATE NAME

The name of this professional service corporation is VICTORIA ROTH-ROBERTSON,

P.A. The principal office and mailing address of the corporation is 5048 28th Avenue SW, Naples,

Florida 34116.

ARTICLE II

DURATION

This professional service corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.
