#### I. Name

The name of the Corporation is Mexican Craft Imports & Exports, Inc.., hereinafter referred to as the "Corporation."

#### П. **Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

# Principal Office and Registered Agent

The principal office of the Corporation is 1192 NW 9th Street, Homestead, FL 33030. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida.
