**ARTICLES OF INCORPORATION
OF
C & J RENOVATIONS, INC.**

The undersigned Incorporator does hereby adopt the following Articles of Incorporation under Chapter 607 of the Florida Statutes, known as the Florida General Corporation Act:

ARTICLE I

NAME AND ADDRESS

The name of this corporation shall be C & J RENOVATIONS, INC. ("CORPORATION"). The street address, along with the mailing address of the principal office of the Corporation, shall be 35022 Glossen Circle, Zephyrhills, Florida, 33541.

ARTICLE II

TERM

The corporation's existence shall commence upon the date of the filing of these Articles of Incorporation, and shall continue thereafter in perpetuity.

ARTICLE III

The number of directors which shall constitute the Board, may from time to time hereafter, be increased or decreased pursuant to any By-Law which shall have been enacted or more specifically ratified by an affirmative vote of the shareholders at any annual meeting or at any special directors meeting.

ARTICLE IV
NUMBER OF AUTHORIZED SHARES

The corporation shall be authorized to issue an aggregate of One Thousand (1000) shares of common voting stock, each such share to have a par value of One Dollar (\$1.00) and all such shares being the same class.

ARTICLE V
PREEMPTIVE RIGHTS

All of the shareholders of this corporation shall be entitled to the benefits of preemptive rights with respect to any uninsured or treasury shares of ownership of this corporation.

ARTICLE VI
RESIDENT AGENT

The street address of the initial registered office of the corporation shall be 35022 Glossen Circle, Zephyrhills, Florida, 33541, and the initial registered agent for the corporation shall be Judith Snee whose address is identical to the address of the registered office of the corporation.

ARTICLE VII
BOARD OF DIRECTORS
