ARTICLES OF INCORPORATION

I, the undersigned, hereby subscribe to these Articles of Incorporation, for the purpose of organizing a professional corporation for profit under the provisions of Chapters 607 and 621, Florida Statutes, and other laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is: CARLOS G. SANCHEZ, P.A.

ARTICLE II

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in every aspect of the practice of medicine. The professional service involved in the corporation's practice of medicine may be rendered only through its officers, agents, and employees who are duly authorized to practice medicine in the State of Florida.

The corporation shall not engage in any business other than the practice of medicine; however, the corporation may invest its funds in real estate, mortgages, stocks, bonds or other types of investments and may own real and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred (100) shares of common stock having a par value of One (\$1.00) Dollar per share.

ARTICLE V
