ARTICLES OF INCORPORATION of

Santana Brothers, Inc.

The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby associates himself/herself to form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this corporation is Santana Brothers, Inc.

ARTICLE II: NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to install and repair ceramic tile and marble products; to have and exercise all of the powers now or hereafter conferred upon corporations by the statutes and laws of the State of Florida. All of the foregoing in this article shall be construed as both objects and powers. The enumeration of specific powers and purpose is not intended to restrict or limit in any way the powers or purposes of this corporation.
