THE undersigned subscribers of these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be DANIEL HELMS GARAGE DOORS, INC.  
498 Kindling Court. Ocoee, FL 34761.

**ARTICLE II. DURATION**

This corporation shall have perpetual existence, commencing December 13, 2001 or as soon thereafter as is permissible by law.

**ARTICLE III. PURPOSE**

This corporation is to engage in the installation of garage doors and any other lawful business and shall have all such powers granted to said corporation by the Statutes of the State of Florida.
