THE undersigned subscribers of these Articles of Incorporation, natural persons competent to contract, hereby form a comporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be DANIEL HELMS GARAGE DOORS, INC. 498 Kindling Court. Occee, Fl 34761.

ARTICLE 11. DURATION
