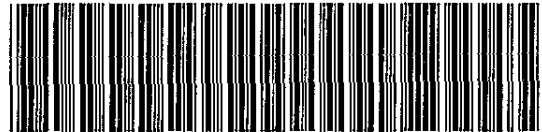

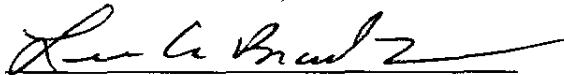
A. Article VII hereby is amended to read as follows:
