# ARTICLES OF INCORPORATION OF HARBORSIDE MORTGAGE OF FLORIDA, INC.



#### Article One: NAME

The name of this corporation is HARBORSIDE MORTGAGE OF FLORIDA, INC.

#### Article Two: Purposes

The corporation is formed for the purpose of engaging in the business of providing mortgage and financial services and acquiring businesses that provide mortgage and financial services and for any other lawful purpose. The corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.
