ARTICLES OF INCORPORATION

OF

THE CAPTAINS STOREY, INC.

ARTICLE I - NAME:

The name of this corporation is: THE CAPTAINS STOREY, I hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
