ARTICLES OF INCORPORATION OF

ARTICLE I

Name

The name of this corporation shall be APARTMENT SOLUTIONS FLA, INC.

ARTICLE II

Business, Objects & Purposes

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation, shall be as follows:

- (a) to engage in the business of finding and soliciting tenants for apartment communities and to act as a real estate broker;
- (b) to invest in real estate, mortgages, stocks, bonds or any other type of investment;
- (c) to own real and personal property necessary for the rendering of corporate services; and,
- (d) in general, to have and exercise all powers conferred by the laws of the State of Florida upon corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE III

Duration


The duration of the Corporation is perpetual.

ARTICLE IV

Capital Stock

- (a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 10,000 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, or in other property (tangible or intangible) or in labor or services actually performed for this corporation, at a fair valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and non-assessable.
- (b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.
