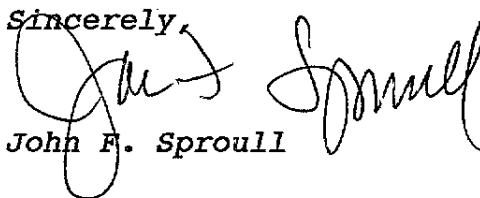

ARTICLE I - NAME

The name of the Corporation shall be EAST COAST SYSTEMS, INC.

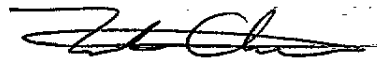
