ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is DENTAL EMERGENCY ROOM OF ORLANDO, INC., and the principal address and principal place of business is 1935 Drew Street, Clearwater, Florida 33765.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 8200 Bryan Dairy Road, Suite 300, in the City of Largo, County of Pinellas, Florida 33777. The name of its registered agent at such address is Steven W. Moore.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK


ARTICLE VI - AMENDMENTS

ARTICLE VII - INCORPORATOR


