
Your representative told us that the 2003 UBR and Fees were received timely, but although the check was deposited on March 6<sup>th</sup>, 2003, she said that the UBR was rejected. She also said that she did not know why the UBR was rejected but also said the rejection letter was never sent.

We were under the assumption the corporation was in good standing until December of 2003. At that time we were made aware that your department has dissolved the corporation. We feel that because we filed timely in 2003, we should not be required to pay a reinstatement fee.

It appears that the logical solution be that we pay the 2004 UBR fee and move on from here.

Your quick response to this action will be very much appreciated, as we are attempting to obtain contractor licensing in LEE County.
