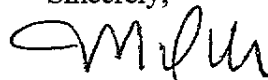

ARTICLES OF INCORPORATION
OF
A & E EXPRESS OF JACKSONVILLE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is A & E EXPRESS OF JACKSONVILLE, INC.

ARTICLE TWO
PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1351 Trade Port Drive, Jacksonville, FL 32218. The mailing address of the corporation is P. O. Box 426, Chiefland, FL 32644.

ARTICLE THREE
CORPORATE DURATION

EFFECTIVE DATE
01-01-02

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is January 1, 2002.

ARTICLE FOUR
CORPORATE STOCK

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE FIVE
REGISTERED OFFICE AND AGENT

ARTICLE SIX

The business of this corporation shall be managed by its stockholders rather than by a Board of Directors. In the management of the business of this corporation, the act of the stockbrokers representing the majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall be the act of the corporation. Each stockholder shall be entitled to one vote in person or by proxy for each share of voting stock held by her or him. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by

proxy shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.

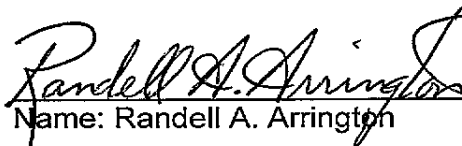

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

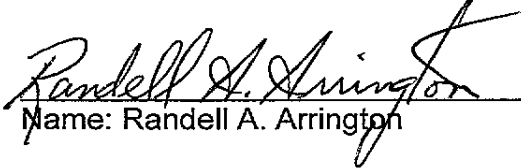
