ARTICLES OF INCORPORATION

OF

AHP OF FLORIDA, P.A.

The undersigned, acting as sole incorporator of AHP OF FLORIDA, P.A., pursuant to Florida Statues, Chapter 621, does hereby adopt and sign the following Articles of Incorporation:

FIRST: The name of the corporation (hereinafter called the "Corporation") is AHP OF FLORIDA, P.A.

SECOND: The principal place of business and mailing address of the Corporation shall be 14050 NW 14th Street, Suite 190, Ft. Lauderdale, Florida 33323.

THIRD: The duration of the corporation is to be perpetual.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares of common stock, having par value of \$.10 per share.
