

ARTICLES OF INCORPORATION OF TARGET III TRUME, INC.

ARTICLE I NAME

The name of this Corporation is **TARGET III TRUME**, INC. and its mailing address s 18400 NW 2nd Avenue, Bay No. 1-A, Miami, Florida 33169.

ARTICLE II NATURE OF BUSINESS

No less than a majority of the directors shall constitute a quorum for a meeting of directors. If a quorum is present, the affirmative vote of a majority of the directors present, or, if a director or directors have abstained from voting because of an interest in the matter to be voted upon, the affirmative vote of a majority of the directors present and voting, shall be the act of the Board of Directors.

ARTICLE VIII VOTING REQUIREMENTS FOR SHAREHOLDERS

The affirmative vote of a majority of the shareholders of this Corporation entitled to vote shall be required for the authorization of any action of the shareholders of this Corporation.


