1. **Name.**

The name of the Corporation is Third Mark of Jacksonville Inc.,

2. **Principal Office and Registered Agent.**

3. **Purposes.**

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.

4. **Capital Stock.**

The total number of shares of capital stock that the Corporation shall have authority to issue is One Hundred ( 100 ), all of which are to be common stock with One Dollar (\$1.00 ) par value.
