Dear Sir or Madam:

This year, we had a change of the principal address, mailing address, and the Registered Agent of this Corporation, from our prior location of 3780 Kori Rd. Suite 4 Jacksonville Florida, under Marcia M. Capron, 930 Murray Drive Jacksonville Florida 32205, under Christopher W. Wickersham. Following those changes, Ms. Capron's involvement with this company was terminated, and her mail was forwarded to her personal residence. We changed our address at approximately the same time as the first request of UBR was sent, and so we unfortunately did not receive this.

As to the second notice for the UBR, though the change of Registered Agents should have been recognized prior to your issuing the second request, the actual request came into this office along with many other things with Ms. Capron's name on them, and still bore her name as registered agent. Thus, this document was apparently forwarded to her at her personal residence. We currently have no contact with Ms. Capron, and did not realize that the document had, in fact, been forwarded to her rather than delivered to me, the proper registered agent, for signature.

As such, I did not receive either of your requests and enclosed forms for the annual UBR and would respectfully request that we allowed to reinstate the corporation as soon as possible, and that the additional \$600.00 fee be waived. We now have forwarding services in place from our old mailing addresses, and have notified everyone with whom we deal, including your office, of this change. We assure you this will not happen in the future, and appreciate your consideration in this matter.
