**ARTICLE I • NAME**

The name of this Corporation is Planetary Enterprises, Inc., principal office and mailing address is 10044 N.W. 46<sup>th</sup> Street, Sunrise, FL. 33351-7937.

**ARTICLE II • DURATION**

This Corporation shall exist perpetually commencing on the date these Articles are filed.

**ARTICLE III • PURPOSE**

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


#### **ARTICLE X • POWERS**




