ARTICLE I • NAME

The name of this Corporation is Planetary Enterprises, Inc., principal office and mailing address is 10044 N.W. 46th Street, Sunrise, FL 33351-7937.

ARTICLE II • DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

ARTICLE III • PURPOSE

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X • POWERS






