

The name of this corporation is STORY ELECTRICAL SERVICES, INC.

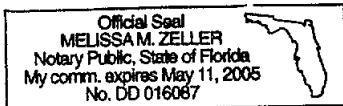




