The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I-NAME**

The name of the corporation is J.K.S. Consulting, Inc.

**ARTICLE II-NATURE OF BUSINESS**

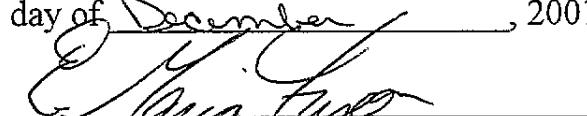

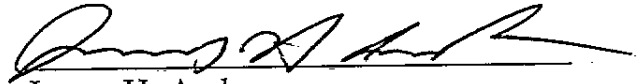
