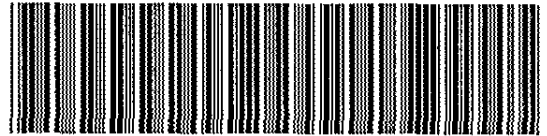

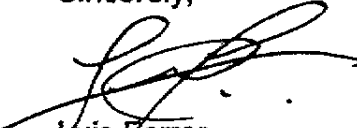

Pursuant to the provisions of 607.1006 of the *Florida Statutes*, Automotive Worldwide Corporation, a corporation organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Section 1 – Name and Background

The name of the Corporation is Automotive Worldwide Corporation (hereinafter referred to as the “Corporation”). Automotive Worldwide Corporation is a corporation organized and existing under the Florida Business Corporation Act, under document number P01000120914, filed in the office of the Secretary of State on December 26, 2001, effective January 1, 2002.

Section 2 – Adoption and Text of Amendments

All of the members of the Board of Directors of the Corporation approved the following resolution amending the Articles of Incorporation by written consent dated December 13, 2002, in accordance with the provisions of Section 607.0821 of the *Florida Statutes* and a majority of the Shareholders of the Corporation approved the resolution the number of votes cast by the shareholders was sufficient for approval amending the Articles of Incorporation by vote on December 13, 2002, in accordance with the provisions of Section 607.0704 of the *Florida Statutes*:

RESOLVED, that Article I of the Articles of Incorporation shall be amended in its entirety to read as follows:

ARTICLE I – NAME

The name of the Corporation shall be Florida Employer Solutions, Inc.

ARTICLE I – PRINCIPAL OFFICE

The address of the principal office of this Corporation is 604 Cedar Bend Cir, Suite #208, Orlando, Florida 32826 and the mailing address is PO Box 5532, Winter Park, Florida 32793.

ARTICLE I – CORPORATE CAPITALIZATION

7.1 The maximum number of shares that this Corporation is authorized to Have outstanding at any time is **ONE MILLION (1,000,000)** shares of common stock, each share having the par value of **ONE DOLLAR (\$1.00)**.

Section 3 – Effective Date of Amendments

The effective date of the Articles of Amendment to Articles of Incorporation of Automotive Worldwide Corporation, set forth herein shall be the date of filing of the Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.
