As of the date of this letter, all of my work done prior to VisionBurst's incorporation must now be removed from both the web site (www.visionburst.com) and any marketing materials (print or other).

For your convenience, it may be left with my parents, whom live in your neighborhood. It must be returned within 1 week from the date of this letter in the same condition in which it was first placed in your use.
