The name of this corporation is:

BUYER'S CHOICE INSPECTION SERVICES, INC.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

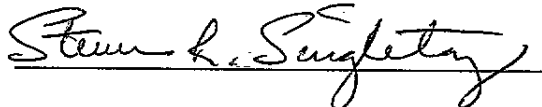

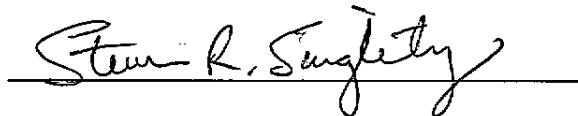
