The name of the Corporation is Discount Auto Outlet of Broward Inc.





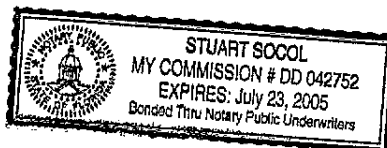
