ARTICLE I CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this corporation is Matthew Kochevar, P.A., and the initial principal address of the corporation is 709 West Azeele Street, Tampa FL 33606.

ARTICLE II NATURE OF BUSINESS AND POWERS
